The ANSI standard has been incorporated as a requirement in "Section 2103.6 Ceramic Tile" of the 2012 International Building Code published by the International Code Council. Average Dynamic Coefficient of friction (DCOF) as found and tested using the BOT-3000E digital tribometer using the SBR rubber slider along with 0.05% SLS (Sodium Laurel Sulfate) solution. **Requirements include those surfaces that are to be walked upon wet shall have a wet DCOF of 0.42 or greater** when tested using the SLS solution per the procedure in Section 9.6.1.

BOT-3000E recalibration due June 17, 2017. BOT-3000E strain gauge verified on day of testing.

### **COMMENT:**

High Dynamic Coefficient of Friction (DCOF) value indicates potentially good traction.

The ANSI A137.1 standard, Section 6.2.2.1.10 states that "Unless otherwise specified, tiles suitable for a **level interior spaces expected to be walked upon wet shall have a wet DCOF of 0.42 or greater** when tested using SLS solution as per the procedure in Section 9.6.1." However, tiles with a DCOF of 0.42 or greater are not necessarily suitable for all projects. The specifier shall determine tiles appropriate for the specific project conditions, considering by way of example but not limited to; *type of use, traffic, expected contaminates, expected maintenance, expected wear and manufacturers guidelines and recommendations.* 

This standard has no recommendation for outdoor floors or ramps.
